

2022-2023 School-Parent Compact

 - Communicate with parents regarding student progress on a regular basis and provide support to parents on school matters
2. Hold parent-teacher conferences (at least annually in elementary schools) during which this compact will be discussed as it relates to the individual child's achievement.
 - Student conferences will be held on a regular basis
 - Parent conferences will be held on an as-need basis, as a result of student, parent or teacher request
3. Provide parents with frequent reports on their children's progress. Specifically, the school will provide reports as follows:

 - Real time information through the parent portal of PowerSchool
 - Counselor, teacher, and administrator telephone contact as needed
